### UMASC/ASCA Show Policies

**All dogs six months of age or over at the show site must have a current rabies vaccine certificate in their owners' possession.**

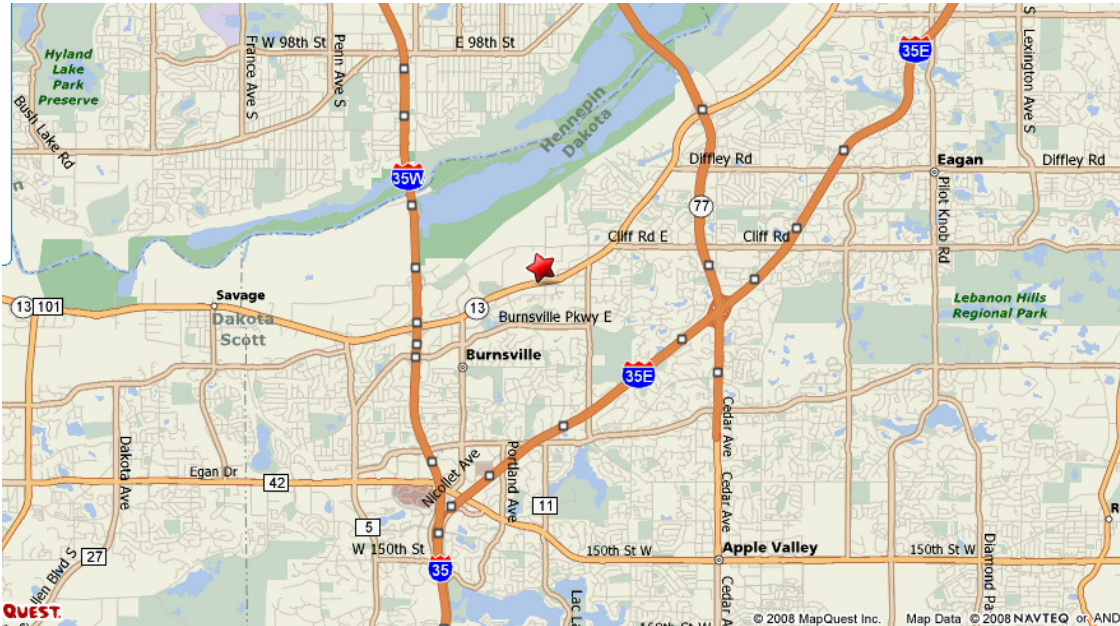
**All Australian Shepherds six months of age and older must be able to show proof of ASCA registration to be eligible for showing.**

**Dogs showing threatening behavior will be subject to either disqualification or excusal, per the ASCA Dog Bite Policy. All UMASC investigations and appropriate forms will be forwarded on to the ASCA Business office. Dogs excused or disqualified under said policy will be excused from the rest of the event and asked to leave, no refunds of entry fees.**
